## **Coast Guard MSU Port Arthur Area of Responsibility:**

Marine Safety Unit Port Arthur's Area of Responsibility extends north to the Oklahoma/Texas and Arkansas borders, South 200 nautical miles into the Gulf of Mexico, East to White Lake, LA, and West to High Island, TX.



Marine Safety Unit Port Arthur serves as the nation's 3<sup>rd</sup> busiest petrochemical port complex and maintains regulatory oversight on the following:

- 96 regulated facilities
- Seven major refineries responsible for the production of 13.3% of the Nation's gasoline production
- Two strategic petroleum reserves that account for 57% of the Nation's total oil reserves
- Refineries along ship channel produce 60% of Nation's commercial jet fuel
- Largest LNG export facility in the United States
- Four major ports: Port Arthur, Beaumont, Orange on the Sabine-Neches River, TX; and Lake Charles on the Calcasieu River, LA
- Home to the Nation's 5<sup>th</sup>, 13<sup>th</sup> and 17<sup>th</sup> busiest ports by cargo tonnage with over 59k vessel transits each year
- 250+ miles of inland waterways; deep draft ship channels and Gulf Intracoastal Waterway
- Two Strategic Military Outload Ports: The Port of Beaumont, TX (the Nation's busiest) and the Port of Port Arthur
- Largest Military Ready Reserve fleet

# Commander Molly A. Wike



Commander Molly Wike joins MSU Port Arthur as incoming Commanding Officer serving Deputy after as Sector Commander, Sector Ohio Valley, and oversaw Coast Guard Operations for an area of responsibility that includes all or part of 10 states ranging from the eastern portion of Missouri to the southwestern corner of Pennsylvania, and from northern Alabama to Ohio. She led over 400 regular, reserve, and civilian men and women, at the Sector office, three Marine Safety Units, two Marine Safety Detachments, as well as six river tenders. These Sector personnel provided maritime security, search and rescue, marine safety, and environmental protection for over

8,000 miles of navigable waterways on twelve major rivers that move \$30 billion in commodity annually.

# Captain Jacqueline M. Twomey



Captain Jackie Twomey assumed Command of MSU Port Arthur on June 20, 2017. As Captain of the Port, Officer In-Charge of Marine Inspections, Federal Maritime Security Coordinator, and Federal On-scene Coordinator, she directs all marine safety, security, and environmental response missions in the third largest bulk tonnage and petrochemical port and the busiest Military Outload operations port in the United States.

From June of 2015 until May of 2017 she served as the Detachment Chief of the Coast Guard National Towing Vessel Center of Expertise. The NCOE maintains trained experts in the towing vessel industry to serve as in-house consultants to the Coast Guard and participates in technical forums and decision-making collaborations,

providing technical advice to industry and the Coast Guard.

Before serving at the Towing Vessel NCOE, Captain Twomey was the Executive Officer of Marine Safety Unit Port Arthur from 2012-2015. 164 personnel served at MSU Port Arthur performing marine inspections, marine casualty investigations, oil spill response, law enforcement, contingency planning, waterways management, vessel traffic management, administration, supply and medical functions. Other assignments include a tour as Prevention Department Head at Sector New Orleans, where she managed 223 personnel, including two WLICs, four Aids to Navigation Teams and Vessel Traffic Service New Orleans. Responsibilities included the busiest Inspections and Investigations Divisions in the Coast Guard, plus a large Officer in Charge Marine Inspections zone inclusive of 980 miles of waterway, 1600 aids to navigation and inspections and investigations in Central and South America.

As an analyst for the Coast Guard's Strategic Transformation Team, she analyzed proposals for the reorganization of the Coast Guard, evaluated organizational design, functional assignments and billet request proposals for consistency with strategic direction. She also served as a staff engineer at both Coast Guard Headquarters and the Coast Guard Marine Safety Center.

A double ended marine inspector and fully qualified marine investigator, Captain Twomey was the Assistant Senior Investigating Officer and marine inspector at Activities Europe, with an Area of Responsibility including Europe, the Middle East and Africa. She received her training during a tour at Marine Safety Office Hampton Roads and, upon earning her qualifications, she was selected to be the Senior Resident Inspector for a shipyard detachment.

Captain Twomey earned a Bachelor of Science degree in Marine Engineering from the U.S. Merchant Marine Academy in 1989. She sailed as a licensed engineer for the U.S. merchant fleet and upgraded her license to Second Assistant Engineer of Steam and Motor Vessels of Unlimited Horsepower. # Rear Admiral John P. Nadeau



Rear Admiral John Nadeau serves as the Commander, Eighth Coast Guard District and is responsible for Coast Guard operations spanning 26 states, including the Gulf of Mexico coastline from Florida to Mexico, the adjacent offshore waters and outer continental shelf, and the inland waterways of the Mississippi, Ohio, Missouri, Illinois and Tennessee River systems.

His previous assignment was as the Assistant Commandant for Prevention Policy, where he was responsible for oversight and program management for all Coast Guard commercial vessel inspections, marine casualty investigations, navigation services, commercial regulations and standards, recreational boating safety, port and facilities safety and security, waterways management, merchant mariner credentialing, vessel documentation, and

port state control.

His first flag officer assignment was as the Assistant Commandant for Capability. In this role, he was charged with identifying and providing service-wide capabilities, and developing standards for staffing, training, equipping, sustaining, maintaining, and employing forces to meet all U.S. Coast Guard mission requirements.

Specializing in Marine Safety, Security, and Environmental Protection for the majority of his career, he served as the Commanding Officer of the Coast Guard Marine Safety Center in Washington, DC and Marine Safety Unit Wilmington, North Carolina. Other tours include Chief of Inspections at Marine Safety Office Corpus Christi, Texas; Senior Investigating Officer at Activities Baltimore, Maryland; and Chief of the Office of Design and Engineering Standards at U.S. Coast Guard Headquarters.

A native of Saco, Maine, Rear Admiral Nadeau graduated from the U.S. Coast Guard Academy with a Bachelor of Science degree in Naval Architecture & Marine Engineering and obtained advanced degrees in Mechanical Engineering and Naval Architecture & Marine Engineering from the University of Michigan. He earned a Master of Arts degree in Homeland Security and Defense from the Naval Postgraduate School, is licensed as a Professional Engineer in Virginia, and an alumnus of Harvard's National Preparedness Leadership Initiative.
